CFTC CHAIRMAN REUBEN JEFFERY III TO ADDRESS MFA AT NETWORK 2006, FEBRUARY 7, IN FLORIDA

WASHINGTON, D.C., January 18, 2006 ---- Reuben Jeffery III, newly appointed chairman of the Commodity Futures Trading Commission (CFTC) will present a keynote luncheon address to Managed Funds Association (MFA), Tuesday, February 7, at noon. More than 500 hedge fund professionals are expected to gather for MFA's 13th annual winter conference, *Network 2006*. The three-day conference runs February 5-7 at The Ritz-Carlton Key Biscayne.

MFA, headquartered in Washington, DC, is the primary trade association representing professionals who specialize in alternative investment strategies, including representatives from the majority of the world's largest hedge funds.
